- Examples:

  - Security cookies (prevent fraudulent activity)
  - Site navigation cookies (enable core website functionality)

### **Performance and Analytics Cookies**

- These cookies help us understand how visitors interact with our website by collecting anonymous data.
- Examples:
  - Google Analytics (tracks visitor behaviour and website traffic trends)
  - HubSpot Analytics (tracks website interactions, form submissions, and visitor insights)
  - o Heatmaps (understand where users click on our site)
- These cookies do not collect personally identifiable information.

# **Functionality Cookies**

- These cookies allow the website to remember choices you make (such as language preferences) to provide an enhanced user experience.
- HubSpot functionality cookies help personalise content and remember previous interactions with our services.

# **Advertising and Targeting Cookies**

- These cookies are used to deliver relevant advertisements and track marketing campaign performance.
- Examples:
  - o Google Ads (tracks conversions from our ads)
  - o Facebook Pixel (helps us retarget website visitors with relevant ads)
  - HubSpot Tracking (used for marketing automation, lead tracking, and targeted email campaigns)
- These cookies may track users across different websites and services.

# 4. Third-Party Cookies

Some cookies on our website may be placed by third-party services we use, such as:

- Google Analytics
- Google Ads
- Facebook Pixel
- LinkedIn Insights
